1. **Eligibility**: The Building Healthy Online Communities' Nice AF Video Sweepstakes ("Sweepstakes") is open only to legal residents of the United States (i.e., fifty states and District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees and contractors of San Francisco AIDS Foundation, as well as the immediate family and household members of each such employees and contractors, are not eligible to participate in the Sweepstakes. Videos should be between 30 and 90 seconds.

The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law. 3. **Timing**: Contest submissions will be accepted until May 26, 2020. The Sweepstakes begins on May 28, 2020, at 12:01 a.m. Pacific Time ("PT") and ends on July 2, 2020, at 11:59 p.m. PT (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.

4. **How to Enter**: The way to register for the Sweepstakes during the Promotion Period is to submit a video through the form on <u>NiceAF.org/submit/</u>

Use of Data: Sponsor will be collecting personal data about entrants, in accordance with its privacy policy. Please review the Sponsor's privacy policy at <u>www.sfaf.org/privacy-policy</u>. By participating in the Sweepstakes, entrants hereby agree to Sponsor's collection and usage of their personal information and acknowledge that they have read and accepted Sponsor's privacy policy.

5. **Prize Drawing**: Sponsor (or Sponsor's Agent) will select, after the conclusion of the Promotion Period, the potential Sweepstakes winner from eligible entries among the five most-voted videos received during the Promotion Period. A winner will be chosen based on the message that best embodies being NiceAF, cohesive storytelling, and total number of votes. Incorporation of humor and creativity encouraged, but not a requirement of winning. The potential winner will be notified by mail, email or phone. Each potential winner will be required to sign and return to Sponsor, within ten (10) days of the date notice or attempted notice is sent, an Affidavit of Eligibility, Liability & Publicity Release ("Affidavit") in order to claim his/her prize of

\$300 USD. If a potential winner cannot be contacted, or fails to sign and return the Affidavit within the required time period, he/she forfeits the prize.
